## **HOW TO CLAIM A TAX DEDUCTION**

Step 1 Complete the attached Notice of intent to claim a tax deduction for personal super contributions form.

This tells us the amount you want to claim.

#### Step 2 Receive confirmation from legalsuper.

Once we receive your form, we'll write to you confirming the amount you want to claim. The 15% contributions tax will then be deducted from your contributions and reported on your next member statement.

#### Step 3 Submit your tax return.

You will need to state the amount you want to claim as a tax deduction in the supplementary section of your tax return.
